Notice is hereby given of a public hearing as required by Section 147(f) of the Internal Revenue Code, as amended (the "Code") to be held on behalf of Arlington Higher Education Finance Corporation (the "Corporation") on March 11th at 9:15 a.m. Central Standard Time, at the below toll-free teleconference number, with respect to the captioned Bonds (the "Bonds") to be issued as qualified 501(c)(3) bonds under Section 145 of the Code in one or more series in an aggregate principal amount not to exceed \$200,000,000 by the Corporation. The proceeds of the Bonds will be used pursuant to a plan of financing described below (collectively, the "Project") and loaned to Responsive Education Solutions, a Texas nonprofit corporation and organization described in Section 501(c)(3) of the Code (the "Borrower") for the following purposes:

- a) Financing and refinancing including reimbursement of expenditures incurred to the extent permitted under the Code the costs of acquiring, construction, improving, and equipping educational facilities including the acquisition of sites for such facilities for pre-K, primary, and secondary school students of the Borrower's schools, at the following locations:

- b) Paying capitalized interest;
- c) Funding a debt service reserve fund and reserves for the project; and
- d) Paying the costs of issuing the Bonds.

The portion of the plan of finance that consists of refinancing prior indebtedness will include refinancing loans made to the Borrower for the purposes identified above through draws on a Line of Credit provided by Regions Bank, under which the Borrower is the obligor.

The Projects will be owned and operated by the Borrower and used in an integrated operation of the Borrower. The Bonds are not payable out of taxes and are secured by and payable solely from funds provided by the Borrower.

The public hearing will be conducted in a manner that provides reasonable opportunity for interested individuals with differing views on both the issuance of the Bonds and the financing/refinancing of the Project to be heard and to present their oral and written comments, and will be conducted by Celeste Kelly, or her designee (the "Hearing Officer"). Pursuant to IRS

Revenue Procedure 2020-49, which provides temporary guidance regarding the public approval requirement under Section 147(f) of the Code for tax-exempt qualified private activity bonds, the public hearing will be available to the public via a telephonic hearing at the following toll-free telephone number:
