INVITATION TO BID RE-BID 22-19: RENOVATION OF VAL VERDE COUNTY FAIRGROUNDS GRANDSTANDS

Val Verde County Judge Lewis G. Owens Jr. and Val Verde County Commissioners Court is soliciting bids for renovation of the Val Verde County Fairgrounds Grandstands, Del Rio, Texas 78840. Sealed bids will be received by Val Verde County Purchasing Department at 509 E. Gibbs Street, Del Rio, Texas 78840 until **2:00 PM on August 30, 2022 (CST)**, at which time and place will be publicly opened and read aloud. Any bid received after closing time will be returned unopened.

All sealed bids must be clearly marked on the outer envelope:
"REBID 22-19: Renovate County Fairgrounds Grandstands"

Sealed Bids are invited for the items and quantities of work as follows:
Remove existing steel purlin and replace with new aluminum planks. The entire Scope and Specifications of the bid can be viewed on the County website.

Bidders shall submit a bid bond by an acceptable surety in the amount of five percent (5%) of the bid issued in excess of \$100,000.00. A certified check or bank draft payable to the locality or negotiable U.S. Government Bonds (as par value) may be submitted in lieu of the Bid Bond.

The successful Bidder must furnish Performance and Payments Bonds each in the amount of 100% of the contract price from an approved Surety Company holding a permit from the State of Texas to act as Surety and acceptable according to the latest list of companies holding certificates of authority from the Secretary of Treasury of the United States, or other Surety or Sureties acceptable to the Owner.

Attention is called to the fact that not less than, the federally determined prevailing (Davis-Bacon and Related Acts) wage rate, as issued by the Texas Department of Agriculture and contained in the contract documents, must be paid on this project. In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, sexual identity, gender identity, or national origin.

Bidders must register on this website in order to view and/or download specifications, plans and other related documents for this project.

The response to these questions will be available on August 19, 2022. All addenda issued for this project will be posted on our county website the following day. It is the responsibility of the Bidder to check the website for any updates. It is the responsibility of the Contractor bidding to use proper scaling, paper width and length, etc. Failure to do so may result in error in the Unit Bid Quantities and/or Bid Amounts.

The Val Verde County Commissioners Court reserves the right to reject any or all bids or to waive formalities in the bidding. Bids may be held by Val Verde County for a period of 90 days or until a contract is awarded, whichever occurs first, from the date of the bid opening for the purpose of reviewing bids. All contractors/subcontractors that are debarred, suspended or otherwise excluded from or ineligible for participation on federal assistance programs may not undertake any activity in part or in full under this project. Val Verde County is an Affirmative Action/Equal Opportunity Employer. Section 3 Residents, Minority Business Enterprises, Small Business Enterprises, Women Business Enterprises, Labor Surplus Area Firms and any other applicable disadvantaged businesses including HUBs are encouraged to submit bids.
