Request for Proposal - RFP 23-04 Long Memorial Park Splash Pad Val Verde County, Texas

Proposals received after the deadline will not be considered for award, regardless of whether or not the delay was outside the control of the submitting provider. Offerors shall submit a bid bond by an acceptable surety in the amount of five percent (5%) of the proposal amount. A certified check or bank draft payable to the locality or negotiable U.S. Government Bonds (as par value) may be submitted in lieu of the Bid Bond.

The successful Offeror shall furnish a Performance and Payment Bond each in the amount of 100% of the contract price from an approved Surety Company holding a permit from the State of Texas to act as Surety and acceptable according to the latest list of companies holding certificates of authority from the Secretary of Treasury of the United States, or other Surety or Sureties acceptable to the Owner. Offeror will be required to furnish bonds within thirty (30) days from the contract date or before commencement of work.
